
Madam/Sir,

The matter was discussed in 22<sup>nd</sup> Standing Committee on Accreditation and Affiliation (SCAA) held on 16.06.2025 and based on the recommendations of SSDEC, SCAA has accepted the de-affiliation of trade/units of 01 Private ITI w.e.f. session 2025-26, and same has been approved by the competent authority.
