Madam/Sir,

This is in reference to minutes of meeting of 7th Skill Development and Entrepreneurship Committee (SSDEC) of Rajasthan State held on 25.03.2025, vide which the de-affiliation of trade/units of 16 Pvt. ITIs were recommended and sent to DGT.

The matters were discussed in 22nd Standing Committee on Accreditation and Affiliation (SCAA) held on 16.06.2025 and based on the recommendations of SSDEC, SCAA has recommended the de-affiliation of 16 Private ITIs w.e.f. session 2025-26, and same has been approved by the competent authority. The details of 16 ITIs are attached at **Annexure - I**.

The recommendation of de-affiliation of ITIs, as mentioned in attached list must be read in conjunction with the minutes of 22nd SCAA meeting.

The Institutes and the State Directorate shall ensure that all the trainees who were already enrolled in the previous sessions, complete the training duration and no fresh trainees are admitted.

Further, the ITIs (S.no 1,2 and 7 as per **Annexure - I list**) are debarred from submitting any application for a period of three years from the date of issuance of this office order.


