This is to inform that 7th meeting of "Sub-committee of NCVT on Norms and Courses" was held on 26th May, 2017 in Main Committee Room, 1st Floor, 'C' Wing, Shram Shakti Bhawan , Rafi Marg, New Delhi under the Chairmanship of DG/ Joint Secretary, MSDE.

Approval of the revised curricula of 7 trades under CTS aligned to National Skills Qualifications Framework (NSQF) was discussed as agenda item no. 8 in the above meeting.

The Sub-committee approved implementation of following 02 NSQF aligned CTS (mentioned in List A) and 05 trades which are re-aligned to higher NSQF level courses under CTS (mentioned in List B) from session starting from August, 2017:

The curricula of above trades have been revised by including new topics relevant to the current market demand (e.g. topics on hydraulics and pneumatics have been added to 'Fitter' trade and also the practical content on CNC turning has been increased in 'Turner' trade). The existing curricula which were introduced in year 2015 shall be discontinued from the forthcoming session. ITIs which have been granted affiliation in existing trades have to create all infrastructure as per the requirement of revised curricula. ITIs desirous of seeking fresh affiliation in these trades are also requested to create infrastructure as per revised norms. The existing affiliated trade/ units for the above 7 trades need to procure the additional tools/ machinery/ equipment within a period of six months from the date of issue of this letter.

Accordingly, State Directors dealing with Craftsmen Training Scheme are requested to issue the necessary instructions to all Government and private ITIs in their State to implement the above-mentioned NSQF-compliant CTS courses w.e.f. session starting in August, 2017.

In this regard, it is clarified that the email sent on 09.07.2018 is intended for the following States/UT, where for admission session August, 2017 NSQF level 5 syllabus is followed for trades Draughtsman Civil, Fitter, Electrician, Electronics Mechanic & Turner and NSQF level 4 is followed in trades COPA & Welder according to the above mentioned letter. The printed theory question papers of semester-II for these trades will be provided to exam centres through speed post and theory question papers for semester-I through e-mail only in these States.
