**Subject: Compliance of the decision taken by NCVT Sub-Committee dealing
with Affiliation during its meeting held on 20.07.2018.-regarding.**

Sir,

The NCVT Sub-Committee dealing with Affiliation held its meeting on 20.07.2018 at Kaushal Bhawan, Karol Bag New Delhi under the chairmanship Sri Rajesh Aggrawal, DG/AS, DGT, MSDE, Govt Of India. Minutes of Meeting is uploaded on public portal ncvtmis.gov.in. Following issues are unanimously decided and needs compliance , in order to ensure the efficiency, effectiveness and transparency as well.

1. You are aware that the Appellate committee constituted by Ministry Of Skill Development & Entrepreneurship vide notification DGT-HC044/456/2017-O/o DD(TC) Dt. 04.01.2018 to deal with all Grievances of ITIs whether emanating from the NCVT decision or on account of QCI inspection.

The Appellate committee had recommended for Joint Inspection of ITIs for taking conclusive decision for affiliation of aggrieved Appellants. It is pertinent to mention that report of joint inspection in many a cases is still awaited.

It is decided that inspection of all such cases which are not inspected yet or those who sought extension of time for inspection , shall be inspected latest by 05th August and report should be sent immediately after inspection for decision of Appellate Committee and further ratification by NCVT Sub -Committee in next meeting.

2. NCVT Sub-Committee also discussed a major issue relating the regularization for shifting of existing ITIs and concluded that "NCVT Sub Committee in its meeting dated 15.02.2018 vide agenda Item No. 3(b) had deliberated on the issue and approved that such ITI , with changed location

which could not be regularized due to closure of QCI portal be exempted from de-affiliation.

ITI of M.P and Karnataka were dealt in line with this resolution. The sub committee agreed to the proposal to extend this facility to ITI in all other states, with a direction to seek application for regularization of all those ITI at the new affiliation portal only. **Land requirement as per new norm, would not be insisted.**

New place should have better infrastructure facilities than the existing one (old one)."

In view of above, you are requested to ensure compliance.
