Sir/ Madam,

This office is in receipt of a letter no. Lr No.D/578/2019 dated 26.02.2019, from the Commissioner, Employment & Training of Telangana State, forwarding therewith the inspection report of the above mentioned ITI (Copy enclosed). The State Directorate has informed that during inspection they have found following Irregularities.

- i. ITI in the campus of SVM Degree and PG college."
- ii. Three colleges i.e., ITI, Degree and PG are functioning in one campus.
- iii. The class room shown by them are using for degree college. On the day of inspection it is found that they were conducted Accounts/Commerce class on the blackboard
- iv. The physics lab shown to the committee as Electrical lab.
- v. Room no. 103 is displayed as computer lab. 18 systems are available.
- vi. Machinery and Equipment for Electrical trade are not installed and dumped in a room.
- vii. Room no. 104 is displayed as computer lab-2 and state that it was DM Civil.
- viii. But drawing tables are not available.
- ix. None of the trainees were available at the time of inspection in all trades.
- Admitted trainees in DM Civil trade are 4 and as per the attendance register only two were present.

Accordingly, the State Directorate Telangana has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your institute.

This office is in receipt of a letter no. Lr No.D/C.NO.213/2019 dated 26.02.2019, from the Commissioner, Employment & Training of Telengana State, forwarding therewith the inspection report of the above mentioned ITI (Copy enclosed). The State Directorate has informed that during inspection they have found following Irregularities:

- i. Saraswathi MPPHW(F) Trg.school, siddipet (PU36000220) is shifted from the address, where it was actually, affiliated. As per the DGT affiliation norms (under instructions for 3.5), if any existing institute relocated a new location without following latest NCVT norms or without written prior approval of DGT/State Directorate, then institute shall be deaffiliation.
- ii. Even at new address i.e, Mathivanam siddipet, there is no training, as the saraswathi MPPHW(F) Training School, Siddipet
- iii. There is no infrastructure facilities as per the norms.
- iv. There are no Tools, Machinery and equipment for Imparting practical training.
- v. The three men committee recommended for de-affiliation of the said ITI (MIS CODE: PU36000220)

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your institute.

Sir/ Madam,

This office is in receipt of a letter no. Lr.No.D/C.NO.3244/2018 dated 05.01.2019, from the Commissioner, Employment & Training of Telangana State, forwarding therewith the inspection report of the above mentioned ITI (Copy enclosed). The State Directorate has informed that during inspection they have found following Irregularities.

- i. There is no 3 phase power supply. Possessing single- phase with meager 1 KW load.
- ii. There are only two shade without any equipment/machinery installed. No class rooms. No ITI lab. Huge shortage of space and overall infrastructural facilities are meager.
- iii. There are no Tools, Machinery and Equipment for imparting practical training.
- iv. Just three instructors are available for 14 units admitted strength.
- v. In view of the above sarada private ITI hayathnagar, Rangareddy Distrgict (PU36000227) is deserved to be de-affiliated and hence it is recommended for de-affiliation with immediate effect.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your institute.

This office is in receipt of a letter no. Lr No.D/5488/2018 dated 23.02.2019, from the Commissioner, Employment & Training of Telengana State, forwarding therewith the inspection report of the above mentioned ITI (Copy enclosed). The State Directorate has informed that during inspection they have found following Irregularities.

- i. There is no machinery and equipment as per syllabus.
- ii. Admissions were very poor in COPA and Draughtsman Civil Trade since there are no training facilities.
- iii. The candidates admitted in R&AC trade also not attending the Institute since the equipment is not available.
- iv. Only one class room is available for all 3 trades.
- v. Three men committee has recommended the said ITI for de-affiliation.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your institute.
