Sir/ Madam,

The 'Diploma in IT, Networking and Cloud' is being run in NSTIs - Bengaluru, Hyderabad, Mumbai & Kolkata and at NSTI (W) – Panipat. Also, few more NSTIs are planning to start the same in the year 2019. In this connection, instructions were issued vide letter no. MSDE-19/02/2018-CD dated 26<sup>th</sup> February, 2019.

- 2. In this connection, it is informed that the assessment guidelines, formats for consolidated and module-wise mark-sheet and certificate for the 'Diploma in IT, Networking and Cloud' have been finalised. The total marks for the diploma have been kept as 1000 including on the job training (OJT).
- 3. Joint certificate for the 'Diploma in IT, Networking and Cloud' (NSQF level 6) will be issued by Directorate General of Training and IBM. The approved assessment guidelines, formats for consolidated and module-wise mark-sheet and certificate are enclosed for necessary action please.
- 4. You are kindly requested to upload the data of diploma trainees on the NCVT-MIS portal once the window for the same is created by CFI section, DGT, HQ. The successful trainees would be issued e-certificates from the portal itself.

- b) The proposed examination structure for each Core Module & Elective Module of the 'Diploma in IT, Networking and Cloud' is as under:
  - i. Total = 100 marks
  - ii. Summative Assessment
    - 1. Theory = 30 marks (Computer based, multiple choice questions with four options)
    - 2. Practical = 30 marks
  - iii. Formative assessment = 40 marks

### c) Preparation of Question Bank:

- i. IBM will provide question bank with 500 questions for each of the 8 modules (5 core and 3 elective) for theory as well as practical papers to DGT, with varied difficulty level (50% questions with simple difficulty level; 30% questions with medium difficulty level and 20% questions with high difficulty level).
- ii. Weightage of marks to be specified by IBM for each learning outcome of each module.
- iii. The question bank with 300 questions for the module 'Employability Skills' shall be prepared by IBM in consultation with TT Cell, DGT (HQ).
- iv. The Question Bank will be displayed on http://bharatskills.gov.in.
  The question paper for the theory, practical and Employability

- Skills examination would be set by TT-Cell, DGT (HQ) from the above question bank.
- v. The theory examination of 30 marks for each module will be held at the end of approximately 1 & ½ years i.e. immediately on completion of the 8 modules and before commencement of OJT.
- d) Formative assessment will include the internal assessment during each module and marks for attendance etc. Formative assessment of the trainees shall be done by the faculty. This will include continuous evaluation of theory, practical, coding etc.
- e) The trainees will be evaluated for 'On the Job Training' (OJT) at the end of approximately 2 years by a committee consisting of faculty from the concerned NSTI and representative from IBM. Total marks earmarked for formative assessment during OJT are kept as hundred, twenty for attendance during OJT and twenty each for assessment at the end of each month in the first four months of OJT, to be assessed during the visit of faculty from NSTI to the office of the Industry Partner.
- f) The examination schedule for the final examination will be notified by TT Cell, DGT (HQ).
- g) A total of two supplementary exams will be allowed for the final diploma exam with an interval of 3 months between each exam. After successful admission, a maximum duration of 3 years will be given to complete the diploma.
- h) The question paper for the practical examination will be set by the respective institution/ DGT in consultation with IBM.
- i) Joint certificate for the 'Diploma in IT, Networking and Cloud' (NSQF level 6) will be issued by Directorate General of Training (DGT) and IBM.
- j) All data pertaining to the Diploma trainees will have to be uploaded on the portal. Thereafter, e-certificates would be issued to the successful trainees.
