3. No staff are available except Sri Satyanarayana, TO and Sri Naveen correspondent.
4. ITI premise are very ugly and seems that not opening the workshop regularly
5. No sign board at entrance
6. No drawing hall is available
7. No staff records are available
8. Power supply is not available as per norms.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your Institute.

This office is in receipt of a Letter No. Lr No. D/ 1570/ 2019 Dated 03.05.2019, from the Commissioner, Employment & Training of Telengana State, forwarding therewith the inspection report of the above mentioned ITI (Copy enclosed). The State Directorate has informed that during inspection they have found following Irregularities:

1. The ITI functioning in the three floor multi stored building. There is no certificate regarding safety/suitability of structure to the trades from civil/ Government structural engineering.
2. No CNC milling trainer and lathe machine for fitter trade. There is no space for erection of heavy machinery pertaining to fitter trade.
3. There are no workshops for electrician trade, electronic mechanic and fitter trades, however they have arranged in hall and bedrooms of 3BHK flat.
4. 60% of the tools, machinery and equipment are shortage in electrician, fitter and electronic mech. trades.
5. The power required to run the above trades are 11.75 KW ant the available power with the institute is 8 KW.
6. There is no IT lab.
7. At the time of the inspection only 2 teaching staff is present in the institute.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your Institute.

1. As per physical condition the I.T.I is not functioning and trainees are appearing for A.I.T.Is regularly.
2. Power required is 22.20 KW. But no three phase power is available at ITI. Hence there is total shortage of electrical power supply.
3. The machinery is in dumped condition for all trades.
4. No workshops and class rooms.
5. No trainees and no staff available. The institute is closed.
6. The ITI is locked condition but batches are running in the portal.
7. Trainees are appearing examinations regularly in semester exams.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your Institute.

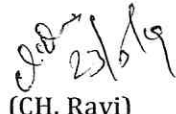

1. There is no three phase power supply to the ITI and it is observed that the power supply is on sharing basis from neighbor house with separate sub meter for this ITI.
2. There are no tools, machinery, equipment for existing electrician, fitter and diesel mechanic trades.
3. There is no registered lease agreement for the building.
4. Except affiliation order there are no other documents available as per norms.
5. It seems that there is no imparting of training programme.
6. The RDD (App), Warangal inspected this ITI one year ago, even after his visit, the management has not taken any steps for development of the institute.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your Institute.

1. As per NCVT MIS portal the address is in pahadinagar, bhuvanagiri but the ITI is now located in Ravindrabharathi nagar, bhongir
2. No sufficient tools, machinery and equipment's electrician 2(1+1) units except a few old motors and panel boards are available without power supply
3. No principal is present on the day of inspection and not showed the staff and students attendance register.
4. No 3 phase power supply to the institute and having single phase supply with 1 KW only
5. No IT lab available
6. No practical trainings imparted and no classes are conducting as per syllabus.
7. Only 1 instructor is available at the time of inspection.
8. The work shop area for electrician 1(1+1) units is not as per norms.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your Institute.

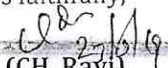

This office is in receipt of a Letter No. Lr No. D/ 1696/ 2019 Dated 07.05.2019, from the Commissioner, Employment & Training of Telengana State, forwarding therewith the inspection report of the above mentioned ITI (Copy enclosed). The State Directorate has informed that during inspection they have found following Irregularities:

1. At the time id inspection of the ITI, there is no staff available in the premises. And there is no trainees present at the ITI, except Sri Srinivasa Rao who is the watchman-cum-sweeper.
2. All the workshop are in locked condition, when the committee asked Srinivasa Rao to open the workshop he replied that "their Sharma sir is not available and he is their school"
3. It came to know from Srinivasa Rao that only two technical staff members are working in the ITI
4. Another technical staff went to Hyderabad on his personal works.
5. One of the technical staff is working as driver to the rower's car.
6. There is no workshop for fitter trade, but few vices fitted on the table along with scrap material which is dumped in the locked room. (observed form the girls.)
7. Machinery like lathe drilling etc. of fitter trade are not in working condition and they are in condemned condition.
8. Electrical workshop is locked in the first floor of the ITI building which is also locked during the inspection
9. It is observed form the girls that condemned motors without electrical connection are fitted on the beds.
10. No electrical panel board is available in the electrician workshop
11. Condemned engines are dumped line men of that area came to the ITI to issue monthly electrical bill. On observing the bill. It is in the name of M/s. Lakshmi industries. The SI.NO. of same electric meter is fitted at the electrical workshop, it is also observed that this motor is shared with an Ice-cream factory located beside the I.T.I. the total load is 5KW/ 3-phase.
12. Class rooms, workshop including principal room are very dirty and it seems that they are opened long back.
13. Over all, it seems that there is no regular training program conducted in this institute.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your Institute.

This office is in receipt of a Letter No. Lr No.D/ C.No.281/ 2019 Dated 26.03.2019, from the Commissioner, Employment & Training of Telengana State, forwarding therewith the inspection report of the above mentioned ITI (Copy enclosed). The State Directorate has informed that during inspection they have found following Irregularities:

1. Out of 262 seats, 226 trainees are on roll, out of witch just 6 trainees were present on 23.2.2019.
2. The electric power is 10KW as against to the requirement of 27.35 KW with a huge deficiency of 17.35 KW
3. As per the norms, 17 faculties are required, but there are only 3 faculty member with a deficit of 14.
4. No workshop for mechanic diesel trade. The workshop meant for fitter, electrician and mechanic R&AC are dirty and there is no sign of conducting practicals.
5. Tools, machinery and equipment are about only 20% available, with a deficit of about 80% as per the norms in respect of the trades mechanic R&AC and mechanic diesel. The available 20% machinery and equipment are also outdated and not functioning.
6. There is huge deficit of tools machinery and equipment in mechanic R&AC and mechanic diesel.
7. There is no faculty for the trades' mechanic R&AC and mechanic diesel.
8. There is huge deficit of power. The available power is adequate for the trades electrician (1+1) units only. For the remaining trades and units the power is short.

Accordingly, the State Directorate has recommended De-affiliation of your ITI for the trade/units as mentioned above, from NCVT. In view of above, you are requested to clarify why action should not be initiated to de-affiliate your Institute.

Three Men committee has inspected said ITI and submitted its report and found that "the Dr.BR.Bmbedkar ITC, Narsampally is not located in Narsamapally and earlier it was run at Ananthagiripalle (Main road, Tooprn to Gajwal main road opposite to Sri Laxminarasimhaswamy temple road, Nacharam).
