Subject: - Compliance of directions passed by various Hon'ble High Courts in the matter of De-affiliation of ITIs Sir,

With reference to the above subject, it is informed that a number of writ petitions were filed before the various Hon'ble High Court(s) by the aggrieved institutes against the decision taken by the Recommendation committee DGT in its meeting held on 28th March 2019, where committee vide agenda item No. 2.4 & 2.5 had recommended for De-affiliation of 305 ITIs. And the Hon'ble High Courts have granted interim exemption in most of the cases.

- 2. In compliance of interim orders passed by the different Hon'ble High Courts in these matters, competent authority at this Directorate General had already reviewed the matter and issued its decision on 11.06.2019 that the decision taken by Recommendation Committee DGT vide Agenda Item No. 2.4 & 2.5 in its 2nd meeting held on 28.03.2019 regarding De-affiliation of ITIs, will be kept in abeyance till further order.
- 3. However, despite interim directions by various Hon'ble High Courts and in compliance thereto clear instructions issued by this Directorate General vide its letter dated 11.06.2019 (copy attached) a number of representations are being received at this Directorate General from the litigant institute(s) requesting to ensure compliance of the interim directions of the Hon'ble High Court(s) and to include the name of their institute(s) in the seat matrix for counseling/admissions for academic session 2019-2020.
- 4. As the aforesaid 305 institutes are eligible to be treated as affiliated till further order(s) you are requested to kindly ensure that the name(s) of these institutes are included in the seat matrix for counseling/admissions for the academic session 2019-2020.

Subject: Compliance of directions passed by various Hon'ble High Courts in the matter of decision taken by Recommendation Committee DGT vide Agenda Item No. 2.4 & 2.5 in its 2nd meeting held on 28.03.2019 regarding De-affiliation of ITIs.

Whereas, during the 2nd meeting of Recommendation committee DGT held on 28th March 2019, committee had recommended for De-affiliation of 305 ITIs as detailed bellow:

Whereas, the De-affiliation of 305 ITIs had recommended based on the proposals received from the respective State Directorates indicating therein irregularities/non-compliance of affiliation norms and after proper scrutinizing of each show cause reply received from the concerned ITIs. However the Speaking order in this regard was yet to be issued.

Whereas, DGT had received a more than 30 Writ petitions on these De-affiliation matters during intervening period and the various Hon'ble High Courts have granted interim exemption in most of cases. Further, DGT had also received many complaints from various ITIs and some new facts have emerged on this issue.

In compliance of the interim orders passed by different Hon'ble High Courts in these matters, the competent authority at this Directorate General has decided that the decision taken by Recommendation Committee DGT vide Agenda Item No. 2.4 & 2.5 in its 2nd meeting held on 28.03.2019 regarding De-affiliation of ITIs, will be kept in abeyance till further order.
