At the outset, Shri Rajesh Aggarwal, DG/AS, DGT welcomed all the committee members and addressed that in order to cope up with the task of granting affiliation to the institutes and maintaining therein quality standard of training DGT needs to refine its standard operating procedure (SOP) for affiliation. He suggested exploring the scope as follows:-

- 1) Affiliation process shall be simplified for every stakeholder.
- 2) The time frame shall be minimized to grant affiliation of new Trades/units/shifting in existing good ITI's
- 3) Mobile application(s) shall get developed or adopted so that real time reporting of inspections of ITIs could be possible to be furnished by the assessors/inspection team.
- 4) Inspection reports shall get accepted only if it is received electronically.

#### **Agenda Item no. 4. 2**

#### **ONLINE ADMISSION IN ALL STATES FROM SESSION 2020**

Committee was informed that at present "Online Admission" is followed only in few states. The committee agreed to the proposal that all State Governments shall follow 100% Online Admission from Session 2020 so as to ensure transparency in Admission process. Further, untoward issue w.r.t data migration possibly will be avoided.

##### AFFILIATION OF ITI'S WHICH ARE JOINTLY INSPECTED

Committee was informed that some existing ITIs which had applied on "Online Affiliation Portal" for seeking affiliation but the same could not be processed by respective State Directorate due to Administrative reasons, were taken up for processing Offline. Accordingly, Joint Inspection Teams conducted inspections of these ITIs. Out of total 407 ITIs, DGT received only reports of 99 ITIs. Upon consideration of the Inspection reports, the Recommendation Committee approved a total 56 nos. of proposals for grant of affiliations as per detail given below:-

#### Agenda Item no. 4.5

##### REVIEW OF DECISION TAKEN ON DE-AFFILIATION PROPOSALS FORWARDED BY STATE DIRECTORATES IN 2<sup>ND</sup> RECOMMENDATION COMMITTEE MEETING, VIDE AGENDA ITEM NO. 2.4 & 2.5

It was informed to the Committee that during 2<sup>nd</sup> Recommendation committee meeting held on 28<sup>th</sup> March 2019, committee had recommended for De-affiliation of 305 ITI's as detailed bellow:

De-affiliation of 305 ITIs was recommended based on the proposal received from State DETs indicating therein irregularities/non-compliance of affiliation norms and after proper scrutinizing of each show cause reply received from the concerned ITIs. However the Speaking order in this regard is yet to be issued.

It was further informed that DGT had received 31 Writ petitions on these De-affiliation matters during intervening period and almost majority of them had got the stay from Hon'ble courts. Further, DGT had also received many complaints from various ITIs and some new facts have emerged on this issue.

In view of above facts and circumstances, the committee reviewed its decision taken in its meeting held on 28<sup>th</sup> March 2019 regarding De-affiliation of ITIs. After detailed discussion, it was decided by the committee to conduct a joint inspection of all these ITIs before taking further decision in the matter. Further, in compliance of the interim orders passed by different Hon'ble High Courts in these matters, committee decided that the decision of de-affiliation will be kept in abeyance till the reports of joint inspection are not received.

##### **SURRENDER OF 3 ITI'S IN PUNJAB**

State Directorate, Punjab had forwarded proposals for de-affiliation of three private ITI. The matter was discussed in 1<sup>st</sup> Recommendation Committee DGT meeting held on 17<sup>th</sup> January 2019. During the discussions, members opined that the same may be verified through RDSDE, Punjab before De-affiliating. Accordingly RDSDE, Punjab was requested vide letter dtd. 23.01.2019 and as per its report vide letter no: NSTIL-A/19011/De-aff/Punjab/2018/Estt/117 dt. 10.05.2019 the following ITIs have been recommended for de-affiliation:
