1. Trades/Units were recommended at S.No-6 of the recommendation report inspite of deficieny mentioned at S.No-1(Defects & Deficiency)
2. In some cases, defects & Deficiency: Nil" and but not recommended.
3. Under defects & Deficiency shortage is mentioned whereas tool list it was mentioned 100% available.
4. Electricity load not verified.
5. Land documents and drawing not verified.

It is therefore requested joint inspection to be carried out in detail and report should be clear. The Joint Inspection of the ITIs will be carried out from 29/07/2019 to 03/08/2019 and Joint inspection reports should reach us by 06/08/2019

In case if any ITI is not ready/willing for inspection as per the schedule, the same ITI's will not be inspected again for grant of Affiliation for the Session 2019-20.
